Continuity and Change of Built Environments - Housing, Culture and Space across Lifespans

Context

Complex and fundamental changes in demographic, economic, social, cultural, technological and environmental conditions are influencing people and their built environments their lives and cultures all around the world. To ensure a functional continuity of housing and space across the lifespan and the construction of housing to meet specific local requirements, a reinterpretation of accumulated experience and knowledge is required for future developments. Drawing on lessons from the past, research in current contexts and creative foresight, this symposium will consider possibilities for future housing, culture, and space for people, lifestyles, cultures and populations undergoing change.

Key Questions

- What is the influence of changing demographic, economic, social, technological, and environmental circumstances on housing, culture, and space?
- How can housing assimilate changing needs and uses of space over time?
- What ensures continuity of past, present and future housing environments?
- What is inter-relationship between housing and the localized situations within which the housing is embedded?
- What lessons can be learnt from traditional housing, culture and use of space?
- What is the future of existing housing, construction materials and building technologies?
- How adaptable are new housing concepts, technologies, building materials, management structures and housing designs to continuity and change in lifestyle and use of space?
- What are the future housing needs and functional requirements of specific user groups (children, youth, handicapped, elderly, etc.)?
- What are the implications of urbanization, migration and workforce mobility for housing in localized situations?
- What are the spatial planning and infrastructure considerations for housing continuity in urban, rural and remote locations?
- With increasing awareness of the ecological footprint of built environments, how will future housing stocks address changing environmental concerns, public and private transportation needs, the food chain, water and energy supply, etc.?

- Defining continuity and change for future built environments
- Influences on housing, built environments and space
- Reinterpreting localized situations in changing global circumstances
- New approaches to future housing construction
- Spatial planning considerations for continuity and change in localized situations
- Housing for diverse user groups and/ or functional capacities
- Environmental context
- Implications for design theory, research and teaching
